However, the charterer remains responsible for the charterer's negligent acts, and for the negligent acts of his or her crew. The charterer understands that all passengers with the exception of any skipper provided by Superior Charters, Inc. are considered guests of the charterer. Charterer is responsible for the safety and well being of charterer and all crew. Children under the age of 18 must be signed for by a parent or legal guardian.
